Three registration forms are attached: One is the SSL (Strongsville Swim League) consent and release form, one is the SSL spectator code of conduct, and the other is for the Deerfield Lake Chandler Commons Swim Team. Please fill out all forms completely and bring them to the **Saturday, March 18 meeting to be held from 12-2 pm at the Deerfield Lake Clubhouse**, or deliver them to Laura Painter at 19967 Hazen Drive, Strongsville, OH 44149.

### **Eligibility:**

The SSL is not intended to be a competitive league, but swimmers must meet minimum criteria to participate. A swimmer must be no older than 18 by June 1, 2017. Younger children must have some swim ability, in addition to being able to follow directions. Some children may occasionally need to touch the lane line to swim across the pool, but for safety reasons, swimmers who need to continuously hold the lane line may not be able to participate in meets. Starting this year, coaches are not permitted to swim in the same lane with younger swimmers during meets. However, we encourage our coaches to get into the pool with the younger swimmers during practice. Coaches will make the final determination of a child's ability to swim the length of the pool safely.

### **Fees:**

**The registration fee per swimmer is \$75.** The estimated cost per swimmer is \$120, but due to fundraisers and the support of our homeowners associations, we have been able to reduce that cost. This fee includes a one-time \$5 technology fee to offset the cost of a new team computer. **All registration fees are due by May 1.** Please bring the registration forms and fees to the March 18 registration meeting if possible, or deliver/mail them to Laura Painter at 19967 Hazen Drive, Strongsville, OH 44149 if you're not attending the meeting.

### **Registration Meeting:**

The registration meeting will be held **Saturday, March 18 at the Deerfield Lake Clubhouse from 12-2 pm**. Please bring printed and completed registration form and fees.

**Swim Suits:** At the meeting a “fit kit” will be available for swimmers to try on swimsuits. Competition-style swimsuits in our team colors are preferred but not required.

**Spirit Wear:** GatorWaves spirit wear will be available to purchase by placing an order. Order forms will be provided at the March 18 meeting.

**Donation:** We are asking each family to contribute a beverage to the concessions for the season. This is a one-time donation of soda or a sports drink (such as Gatorade or Propel). People whose last name begins with A-L, please provide soda (12-pack); M-Z please provide a sports drink (8- to 12-pack). Thank you!

Swimmers must be ready to swim (caps and goggles on, etc.) at the start of each warmup.

### **Practice Times:**

Due to a Chandler Commons HOA change, all Chandler Commons swimmers will practice from 9-10 am. We realize some older swimmers may want to practice at the same time as last year (10-11 am). Because of this, all Chandler Commons swimmers have the option to practice at the Deerfield Lake pool (9-10 am for 10 & Under, 10-11 am for 11 & Over), assuming transportation is provided to and from practice. Deerfield Lake residents will practice at the Deerfield Lake pool. Due to the limited practice time at Chandler Commons, we will have combined **Fun Fridays at the Deerfield Lake pool every Friday**.

***Optional evening practices will begin Tuesday, May 30.*** Times will be determined later.

***Mandatory swim practices will begin Thursday, June 8. Fun Friday practices are optional.***

#### Chandler Commons Pool:

All swimmers — 9-10 am *(or can practice at Deerfield Lake pool during times on left)*

### **Championship Meet (Champs):**

The Strongsville Swim League (SSL) championship meet will be held on **Saturday, July 15, 2017**. As with any meet, we have required jobs for this big meet. Each family with a participating swimmer will have a volunteer responsibility.

### **Parent Responsibilities:**

**Parent involvement is the only way this league can exist.** It is very important for each family to do its part. As we approach the season, we will send a link for you to sign up for jobs for all meets. Please consider doing something other than timing or awards. We need all positions filled. We are happy to walk you through a new position until you are comfortable.

**Each family will be expected to participate in approximately 7 half-meet job assignment times** during the season depending on the number of families registered. Job assignments generally come from the following committees: Concessions, Scoring, Timing, Clerk of Course, Announcing, Awards and Runner.

If a family does not sign up for jobs, you will be assigned them. It is your responsibility to get coverage should you not be able to fulfill your obligation.

### **Swimmer Responsibilities:**

Swimmers are responsible for following these rules at practices and swim meets:

1. Attend all scheduled practices.
2. Be on time to be eligible to swim in a meet.
3. Respect the instructions and decisions of the coaches, and be respectful and cooperative at all times.
4. Inform coaches if you will not be able to attend a practice or meet.
5. Disruptive behavior will be subject to discipline, and parents will be consulted if problems are persistent.

## Strongsville Swim League Swimmer, Parent, and Spectator Code of Conduct

1. Swimmers/parents/spectators should remember that the goal of summer swim league is: TO SUPPORT CHILDHOOD GROWTH AND DEVELOPMENT THROUGH SWIMMING-the fundamental techniques will be emphasized, with focus on sportsmanship, teamwork and having fun!
2. Swimmers/parents/spectators should keep in perspective what Strongsville's swim league is about - through sports; a child can experience attitudes which can help shape a happy, productive, and well-adjusted life. By creating a healthy environment on the team, ALL CHILDREN CAN BE WINNERS, regardless of the won-lost record.
3. Our children learn from what they observe- let your behavior '**SET THE EXAMPLE**' for our swimmers!
4. Parents/spectators should remember they are present to support the children, not to draw attention to themselves.
5. Parents/spectators should remember that coaches and officials are trying to help our children and are qualified in swimming. Unless they are invited to take an active part in coaching, should not complain/offer advice from the deck/gallery.
6. The official is in complete charge of the meeting and for the sake of the swimmers, his/her decision must be respected. If there is a complaint, it must be brought to your team President who will then take it to the SSL President if further action is needed.
7. Swimmers/parents/spectators who attend swim meets should promote wellbeing and cheer for a job well done, regardless of which team the child is swimming for. Bullying another swimmer is NOT TOLERATED.
